## **GENERAL INFORMATION**

**In accordance with Organization Bylaw 14 the following member voting rights are in effect for the Annual General Meeting (AGM):**

14.1 A full membership carries full voting rights. An individual with a full membership, may compete and/or coach at all levels of competition, serve on committees, and/or become qualified judges and officials at all levels of competition. A full membership entitles those over the age of 18 full voting rights. An individual under the age of 18 who carries a full membership may transfer their voting rights to one parent or guardian.

14.2 A recreational membership carries limited voting rights. An individual with a recreational membership may participate in all recreational activities. A recreational membership entitles those over the age of 18 limited voting rights, as defined by the Canadian Not-for-Profit Act. An individual under the age of 18 who carries a recreational membership may transfer their voting rights to one parent or guardian.

14.4 A club membership carries full voting rights and allows incorporated member clubs one vote at the Annual General Meeting.

14.5 A Provincial Sport Organization membership carries limited voting rights as defined by the Canadian Not-for-Profit Act.

14.6 Limited voting rights are as defined by the Canadian Not-for-Profit Act and include dissolution of the organization and constitutional changes.

## **REGISTRATION STEPS**

**STEP 1: Determine your membership type (as above). You may register to attend the AGM as one of the following:**

- Full Member
- Parent/Guardian of Full Member
- Recreational Member
- Parent/Guardian of Recreational Member
- Member Club Delegate
- Member Provincial Sport Organization Delegate

### **STEP 2: Delegate Registration**

All attendees must register using the RSC Declaration Portal. Information submitted in this declaration will be verified against the current RSC Membership database to determine voting privileges for declared members.

### **STEP 3: Proxy Submission**

For those members who cannot attend the RSC AGM but would like to assign a Proxy holder for their vote, a Proxy Form must be completed and submitted no later than **September 19, 2021 at 11:59 am EDT** to [secretary@ropeskippingcanada.com](mailto:secretary@ropeskippingcanada.com). The RSC AGM Proxy Form can be found on the [RSC website](#) under the 2021 RSC AGM Package.

At the time of the meeting, proxy holders can inquire about the total number of votes they hold.
